**Sub: Recovery of Pro- rata charges on per KVA basis from the consumers/beneficiaries.**  
**Ref:** (1) Commercial Circular 18 issued vide L.No. GETCO/ACE(R&C)/532 Dtd 12-04-2019.

In continuation to Commercial Circular No 19 and on approval of Competent Authority it is decided to recover Pro-rata charges as mentioned below from all HT and EHV applicant registered applications for new connection, additional load and conversion for LT to HT/ HT to EHV from 01.04.2020 up to 31.03.2021.
